

100% Credit Bonus Terms and Conditions

1. INTRODUCTION

- 1.1 Royal ETP LLC "ONEROYAL" offers this "Bonus" campaign ("Program" or "Promotion"). The Campaign is only provided to the selected group of Participants (hereinafter referred to as: "Investor", or "You" or "Client") under certain Terms and Conditions. The Bonus is not transferable and is solely limited to the recipient of this Program.
- 1.2 By participating in this Program, the Participant hereby agrees to be bound by the below Terms and Conditions.

2. ELIGIBILITY CRITERIA

- 2.1 Under this Program, Participants shall benefit from the following offer, provided that the Program applies only to Real account(s).
- 2.2 Under this Program, the Investor shall benefit for one time from the following offer, provided that the Program applies to Real account(s). The Account Value may from time to time reflect any such aggregation or set off any debt or other amount owing.
- 2.3 The Investor acknowledges and agrees hereby that he/she shall benefit from the following Program that applies only to Classic Account and ECN Account on MT4 and MT5.
